Columbus, Ohio RTNI Urban Plunge – Summer 2020

The Columbus, Ohio RTNI Urban Plunge is a unique and unforgettable service-learning experience. We stay in the home of Aaron and Emily Starr, two wonderful young people who founded and run an inner-city ministry in Columbus OH called *Reaching The Nations International* (www.reachtni.org). Their Urban Ministry includes *Youth Bible Study* for ages 5 – 12, *Proverbs 31 Girls* which teaches girls ages 9 – 18 basic life skills, *Money Talks*, their financial literacy program for ages 13 and up, one-on-one tutoring and *Young Gardeners of Milo*, a 1000 sq. ft. garden project. Their global ministry includes work in Haiti, Venezuela and India. Their unofficial ministry includes hanging out with neighbors in their home and connecting neighbors with resources when possible. Their ministry house is located at 837 East 2nd Avenue, Columbus, OH, 43201.



Brief History: Emily Starr (Lange) is the daughter of Jerome and Paula Lange, our friends in Liberty, KY. Emily met Aaron Starr and they married in 2002. They moved to Columbus, Ohio (Aaron worked for CitiBank) and in 2007 they purchased a house in Milo-Grogan, an urban portion of Columbus and started their ministry. During our visits we participate in a variety of activities including service activities with the young people served by the Starrs, working on their new ministry house, hanging out with the teens and sharing life experiences, playing games, doing Bible activities, working in their garden, sometimes visiting The Ohio State University, and much more!

Why do you want to attend the Columbus Urban Plunge?

PARENTS: I, the lawful parent or guardian of _____ (my "child"), request my permission for my child to participate in **Columbus, Ohio Urban Plunge with RTNI Ministries** sponsored by MND according to the terms specified below:

1. I release from all liability, and indemnify and hold harmless Mount Notre Dame High School and the officers, agents, representatives, volunteers, and employees of Mount Notre Dame from any and all liability, actions, causes of action, claims, judgments, costs or expenses, including attorney fees, known or unknown at this time, arising out of or in any way related to any injury or illness incurred by my child while participating in or traveling to or from the activity.
2. I agree to instruct my child to cooperate with MND and their agents in charge of the activity.
- 3a. I appoint MND and their agents who are acting as leaders of the activity as my attorney in fact to act for me in my name and my behalf, in any way that I would act if I were personally present, with respect to the following matters if any injury, illness, or medical emergency occurs during the activity:
 - (i) To give any and all consents and authorizations to any physician, dentist, hospital, or other persons or institutions pertaining to any emergency medications, medical emergency occurs during the activity.
 - (ii) I understand that the agents of MND will make a reasonable attempt to contact me as soon as possible in the event of a medical emergency regarding my child.
- 3b. The powers and authority granted herein may be revoked by me by written notice delivered to MND or any agent thereof who is acting then or who has previously acted hereunder.
4. **PHOTOGRAPHS:** I agree that MND or their agents may use my child's portrait/photograph for editorial purposes and office functions and hereby release Mount Notre Dame and their agents from any liability resulting from such use.
5. **TRANSPORTATION:** I request permission for transportation arrangements as indicated in the application. I acknowledge that we have adequate insurance to cover any claims. I hereby waive and discharge any and all claims, rights of action, demands or liabilities of whatever nature against MND or any and all other person or persons in charge for any injuries or damages which my child, either directly or indirectly, incurs or causes as a result of her being a passenger in a car driven by adults involved in the trip, or as participating in these service activities. I have carefully read this statement, and my signature acknowledges that I fully understand its content and meaning and authorizes my daughter to participate in the activity being sponsored by MND.
